✂ Tuition is due the 1<sup>st</sup> of each month and will be considered late after the 5<sup>th</sup>. **Any past due accounts will be charged a \$20 late fee on the 6<sup>th</sup>.** Check payments with insufficient funds are subject to a \$30 NSF fee. A valid credit card is required to be on file as a **GUARANTEED FORM OF PAYMENT**.

✂ The annual registration fee is \$50 for the first child or \$75 for a family membership. **NO REFUNDS** will be given for the **REGISTRATION FEE** or **TUITION**.

✂ Monthly payments are based on a 48 week business year. Some months have 5 classes, while others only have 3. IGG does not prorate based on holiday closures (Thanksgiving, Winter Holidays, July 4<sup>th</sup> week, etc.).

✂ Missed classes are not refundable or prorated. Make-up classes must be made in advance, or within 1 month of the missed class. Only 1 make-up class per month is permitted.

✂ By signing this registration form you give permission to International Gold Gymnastics to use pictures or videos for advertisements, promotions, and/or social media for the gym.
